SUBDIVISIONS/LAND DEVELOPMENT PLANS

<u>Christopher and Deanna Kolivosky, 105 Colonial Court, Wellsville, PA</u> Mr. and Mrs. Kolivosky purchased a 10.67 acre tract that is Lot 5 of the Thundergust Meadows subdivision. The plan is to use the lot to build a single family dwelling. They are asking for a modification to construct a 40' x 60' pole building to be used for residential storage. The total impervious surface is estimated to be 8,880 square feet. Motion was made by Mr. Bensel and seconded by Mr. Kotz to approve the modification request. Motion carried unanimously.

ZONING HEARINGS

<u>Case 2017-04 Hemauer Brewing Company, LLC - 465 Cabin Hollow Road, Dillsburg, PA 17019</u> The applicant intends to operate a beer brewing operation at this address and is requesting a Special Exception for Rural Occupation pursuant to Section 304(c)(18) of the Ordinance. In the event that the Zoning Board would determine that the proposed brewing operation does not qualify as a Rural Occupation under the Ordinance, the Applicant would suggest that the proposed use is a use not provided for under the Ordinance and the Applicant would seek a Special Exception pursuant to Section 302(b) of the Ordinance. The applicant said there would be no on-site sales, kegging, bottling or taproom. He plans to brew 31 gallons per year. All wastewater will be sent to a holding tank that will be pumped quarterly. A neighbor, Marek Luksic, said he would like the Planning Commission to address noise, odor and water consumption.

Motion was made by Mr. Bensel and seconded by Mrs. Repman to recommend approval of the request for a beer brewing operation at 465 Cabin Hollow Road, Dillsburg, but he would request that the Zoning Board address water consumption regarding well capacity and water table,

potential for expansion, waste disposal and that there would be no signage to attract people to the property.
