The meeting was opened with the Pledge to the Flag.

Minutes. Motion was made by Supervisor Hawkins and seconded by Supervisor DeFrain to approve the minutes of the March 20, 2019 meeting. Motion carried unanimously.

EMERGENCY SERVICES REPORTS

<u>Geisinger EMS.</u> Geisinger ambulance reported an estimated total dispatch of 30 calls in Warrington Township during the month of February 2019. Twenty-five were handled by Geisinger and five by other agencies.

Wellsville Fire Company. The Fire Company reported responding to 11 calls in Warrington Township during the month of March.

<u>Dover Ambulance.</u> A quarterly report was received from Peggy Anderson, Director at Dover Ambulance showing they responded to 7 calls in Warrington Township.

PUBLIC RECOGNITION

Mr. Marcus Sheffer, E Camping Area Road. Mr. Sheffer lives at the dead-end section of E Camping Area Road. The road along his property has not been maintained by the Township for a long time. He is asking that the Supervisors begin maintenance on his section of road. The Board said they would get an answer for him.

SUBDIVISION/LAND DEVELOPMENT PLANS/PLANNING MODULES

<u>Perry Witmer, Planning Module, 340 Fickes Road.</u> Mr. and Mrs. Witmer submitted a Component 2 Sewage Facilities Planning Module for a lot that was created in May of 2018. York County Planning Commission approved their Component 4B and the Warrington Township Planning Commission approved their Component 4A. Motion was made by Supervisor Weaver and seconded by Supervisor DeFrain to table the request for approval until the Township Engineer is present. Motion carried unanimously.

<u>Modification Request – Dennis and Shannon Merovich, 201 Mt Zion Road, Dillsburg</u>. Mr. and Mrs. Merovich are requesting a modification to Section 203 regarding building size and Section 303

requesting a waiver from submission of a land development plan. Their plan is to construct a 1,800 square foot pole building to be used as a residential garage and unenclosed picnic area. The total impervious surface will be 5,560 square feet. Stormwater management is required when the impervious surface is 20,000 square feet or greater. Motion was made by Supervisor Weaver and seconded by Supervisor Hawkins to approve the modification requests. Motion carried unanimously.

Mr. Dennis Hoch, 340 Benedicts Road, Wellsville. Mr Hoch is requesting a modification from Section 203 regarding building size and Section 303 requesting a waiver from submission of a land development plan. His plan is to construct a building 1,120 square feet to be used as a residential garage. Total impervious surface is 4,880 square feet. Motion was made by Supervisor Weaver and seconded by Supervisor DeFrain to approve the modification requests. Motion carried unanimously.
