<u>Minutes.</u> Motion was made by Supervisor Hawkins and seconded by Supervisor Weaver to approve the minutes of the February 19, 2020 meeting. Motion carried unanimously.

<u>Pennsylvania State Police.</u> Corporal Sean Taylor visited the meeting with information regarding State Police calls in Warrington Township during the past year. Corporal Taylor is Patrol Supervisor at York Barracks in Loganville. He brought a report to the meeting that showed a substantial number of calls but most of them were minor. He warned residents to always lock doors and take keys from their vehicles. Thefts are not only happening in urban areas but also in rural township areas like Warrington.

Wellsville Fire Company. The Fire Company reported responding to 8 calls in Warrington Township during the month of February 2020.

### PUBLIC RECOGNITION

Nikos Phelps. Mr. Phelps is organizing an event to be held at Gifford Pinchot State Park on September 13, 2020. The organization is Utopian Events and the event is the Pinda Triathlon Festival. They are expecting 300 to 400 people. Affected roads will be Rosstown Road (Rt 177), Alpine Road and Carlisle Road (Rt 74) during the bike event that will be from 8 AM – 10 AM. Mr. Phelps is requesting Township approval for his event prior to making application for a Special Events Permit from Penn DOT. Motion was made by Supervisor Dockery and seconded by Supervisor Weaver to approve the request for the Pinda Triathlon Festival at Gifford Pinchot State Park on September 13, 2020. Motion carried unanimously.

Robin Crone, Kunkles Mill Road. Mrs. Crone asked if there was an update from the Supervisors on her problem with the goats and horses owned by the Petratos farm running loose on Kunkles Mill Road. Mrs. Crone asked if the Township Ordinance definition would make a difference if

the farm were considered a rescue rather than a farm. The Board told her to keep documenting the incidents in case she files for a District Justice hearing.
