EMERGENCY SERVICES REPORTS

<u>Wellsville Fire Company</u>. The Fire Company responded to 10 calls in Warrington Township during the month of October 2020.

<u>Geisinger Emergency Medical Services – West Shore.</u> There were a total of 166 dispatches in the Northern York division. The preliminary estimate of total dispatches in Warrington Township was 24. Of those, 20 were handled by the Northern York Division of Geisinger EMS. Four were handled by other divisions of Geisinger EMS or another agency.

PUBLIC RECOGNITION

Leon Grove, Carlisle Road. Mr. Grove asked why it takes so long to vote. Supervisor Weaver said he is going to ask Representative Dawn Keefer to move the election location. Larry Anderson, Fire Chief, said Ski Roundtop would be a good location or split the Township into two locations.

Solicitor

Harold Stoneberger. The Solicitor said Mr. Stoneberger did not appeal the Court decision.

<u>Septic pumping.</u> District 4 properties were due to be pumped by August 30, 2020. There are a total of 12 properties still on the list as outstanding, 8 of which have not made an attempt to schedule or notify the Township office of plans to pump. Supervisor Weaver said to have the Solicitor file citations with the District Justice office for the properties that were not pumped. <u>2021 Budget.</u> The Board said to advertise the 2021 Budget meeting on November 11, 2020 at 6:00 PM.

<u>Garage Roof.</u> The contractor who was awarded the bid to replace the garage roof said it would be installed by October 31. The work has not been done and the Supervisors said to call the next in line bidder.

<u>York Adams Tax Bureau.</u> Supervisor Dockery said that although the Tax Bureau predicted a decrease in Earned Income Tax due to COVID-19 employee lay-offs, there has actually been an increase of distributions in the amount of 3.7% in some of their areas.
