By signing this application, I certify that the application and all accompanying documentation are true and correct. This application is being made by me to induce official action on the part of the Township and I understand that any false statements made herein are being made subject to the penalties of 18 Pa. C.S. §4904 relating to unsworn falsification to authorities. I hereby authorize the designated Warrington Township official to investigate, inspect, and examine the property set forth herein, including land and structures, to determine compliance with the Warrington Township Zoning Ordinance and to determine the accuracy of the statements contained herein. The issuance of a zoning permit is based upon the facts stated and representations made in this application. A zoning/building permit may be revoked if use and/or structure for which it has been issued violate any applicable Township, County, State or Federal law or regulation, including but not limited to the Warrington Township Zoning Ordinance. This Permit may also be revoked if it has been issued in error or if issuance was based upon any misrepresentations or errors contained in the application or otherwise made by the property owner.

The Property Owner bears all responsibility for ensuring compliance with all applicable Township, County, State, and Federal laws and regulations. It will be the duty of the permittee to see that the permit is posted in a conspicuous place where the work is being performed and that it is maintained thereon until a use/occupancy certificate has been issued. Any permit issued shall become invalid if the authorized work is not commenced within six (6) months after the issuance of the permit, or if the authorized work is suspended or abandoned for a period of six (6) months after the time of commencing the work. All work must be completed within twelve (12) months of issuance of permit.
