1. Please fill out **ALL** required registration forms included in the **CAMP REGISTRATION PACKET** found on our website or available in the township office. Return to Warrington Township office prior to June 3rd, 2024.
2. **Day Camp is 9:00 AM TO 2:00 PM** at **WELLSVILLE FIRE COMPANY PAVILION, 95 COMMUNITY ST, WELLSVILLE**
3. Drop off your child(ren) at **Wellsville Fire Company Pavilion.**
4. Please **check campers in** at the check-in station. If there is to be an early pick-up or a special concern, please speak to check-in staff.
5. **FOR YOUR CHILD'S SAFETY, PLEASE DO NOT DROP OFF ANYONE BEFORE 8:45 AM AND EVERYONE IS TO BE PICKED UP AT 2:00 PM.**
6. Anyone left late at the park will be taken inside the Fire Company building to wait with a camp volunteer for pick-up.
7. **PLEASE DON'T** take your child away from camp without signing them out with Day Camp staff.
8. **Please** do not bring anyone along to Day Camp who is not registered, such as a friend who spent the night, a relative visiting, or someone you are babysitting.
9. This camp is for Warrington Township residents only and registration is required in advance.
10. Volunteers over the age of 18 are required to have State Police Child Abuse Clearance (arranged through the township).

If we experience severe weather, please pick up your child at the Fire Company building. Also enclosed is an Emergency Contact Form. **No child will be able to attend without this form.**

Remember to send a bag lunch with your child, except on Friday lunch will be provided. Snacks and drinks will be provided each day. Thank you in advance for your cooperation.
